#### **Individual Membership**

Annual Fee – \$1,800 + Tax

Initiation Fee – \$200 + Tax

Initiation Fee will be waived if the Applicant makes one payment of the Annual Fee, in full (\$1,800 + Tax). A monthly installment payment plan for the Annual Fee is also available.

The Initiation Fee must be paid in full when membership is accepted.

#### **Family Membership**

Annual Fee – \$2,800 + Tax

Initiation Fee – \$200 + Tax

Initiation Fee will be waived if the Applicant makes one payment of the Annual Fee, in full (\$2,800 + Tax). A monthly installment payment plan for the Annual Fee is also available.

The Initiation Fee must be paid in full when membership is accepted.

Family Membership is for one primary member plus two secondary members for a maximum of three golfers per Family Membership (no discounts for Family Memberships with less than 3 golfers). For a family membership of more than three golfers, an additional \$500 per family member shall be added to the \$2,800 Annual Fee (i.e., a Family Membership for a family of four golfers will cost \$3,300 + Tax for the Annual Fee plus the Initiation Fee). All family members using the Family Membership must live in same household, and either be the spouse of the primary member, or a minor under 18 years of age in such household.

## **MEMBERSHIP AGREEMENT**

### **Initiation Fee**

The Initiation Fee is non-transferable and non-refundable. Membership will not be activated until the Initiation Fee is paid, unless the Initiation Fee is waived when Member pays the Annual Fee in full.

### **Primary Member**

It is understood and agreed that there shall be only one (1) member per membership (the "Primary Member") and that memberships will not be issued jointly in two or more names. With regard to any disputes about the ownership of a membership, East River 9 shall rely on this Agreement to confirm ownership of the membership in the name of the undersigned, who shall be the Primary Member.

### **Resignation**

This is an annual membership. The applicant will be responsible for the remaining amount of dues owed based on membership type and anniversary date. No money will be returned for any circumstance.

The applicant agrees that in the event of a corporate reorganization or personal divorce, this membership is not divisible, and this membership shall be allocated by agreement of all claimants, or in the absence of agreement, by court order. Such allocations are subject to the sole approval of East River 9. The successor to the membership shall execute all necessary papers and pay all allocation fees required by East River 9. Except as expressly set forth above, all resigned memberships shall revert back to East River 9.

### **Late Fees**

Payment of account is due upon receipt of the monthly statement. Applicant agrees that East River 9 may assess a late charge for pat due accounts of \$25. Applicant agrees to pay all reasonable attorney fees, court fees, investigator fees and any associated costs in the event his account is turned over for collection.

### **Rules of the Club**

Applicant agrees to be bound by the rules and regulations of East River 9 as they may be amended from time to time. East River 9 may host public and private events at its sole discretion which may limit the availability of the golf course, driving range, putting green, pickleball courts, and/or restaurant to members for a limited duration. Members understand and agree that no discount or refund will be extended for such an event.

### **Assumption and Limitation of Liability**

Applicant understands and agrees that Applicant is assuming the obligations to pay the Initiation Fee, the Annual Fee, and all other fees and charges incurred by Applicant, Applicant's family and Applicant's guests in the use of the East River 9 facilities, and that Applicant's membership, upon acceptance by East River 9 (the "Membership") does not confer upon Applicant any ownership, interest, or rights of any nature in East River 9 or its property or assets. Applicant



further understands and agrees that any use of the East River 9 facilities by Applicant, Applicant's family or Applicant's guests is done at their own risk, and neither East River 9, nor its members, managers, officers, employees, agents or representatives, or their successors or assigns (collectively, the "ER9 Parties") shall be liable for theft or loss of personal property occurring at the East River 9 facilities, or the personal injury or death of Applicant, Applicant's family or Applicant's guests occurring at the East River 9 facilities. Applicant agrees to assume, and does hereby assume, without reservations, all risks of injury and death to Applicant, Applicant's family and Applicant's guests, and damage to personal property, whether caused by Applicant, Applicant's family, Applicant's guest or another person at the East River 9 facilities, thereby agreeing to release, discharge, indemnify, defend and forever hold harmless the ER9 Parties from and against any and all claims, actions, suits, procedures, costs, expenses, damages and other liabilities (including, but not limited to, court costs and attorneys' fees) arising out of, in connection with, or otherwise resulting from any injury or death or damage to personal property occurring at the East River 9 facilities, except to the extent such injury, death or damage is the direct result of the gross negligence or willful misconduct of an employee or agent of East River 9. Applicant further acknowledges and agrees that the limitation of liability and indemnification provisions set forth above are fair, reasonable and fully enforceable, and that Applicant's execution of this Agreement is completely voluntary.
